Book Consignment Information

Thank you for your interest in placing your book at The Country Bookseller. If your book has been published by an established publisher or is carried by Ingram at a regular discount and returnable, and we decide to carry it, we will purchase it directly from that source.

If your book is self-published or not readily available through our normal wholesalers or is only available on a short discount/non-returnable basis, we offer you the opportunity for us to sell it on a consignment basis. On consignment, the book remains the property of the consignor until sold. The Country Bookseller is not responsible for lost, stolen, or damaged merchandise. If you would like your book considered for stock, please follow our consignment guidelines:

- Must have an ISBN
- Must have title printed on the spine
- Should be cost effective (\$30 paperbacks totaling 150 pages are hard to sell even if it's the greatest book ever)
- Editors are a plus (even a missing comma or period can be a nuisance)
- Helpful to have a local connection
- To submit a book for consideration, please email a one paragraph letter including your contact information, book title, ISBN, and price information, along with promotional materials, publicity plans, target audience, and any connections to the area. These materials should be sent to books@thecountrybookseller.com with the subject line: CONSIGNMENT. If we feel your book may have a market with our customers, we may request a review copy. Please do not drop off or mail review copies at the bookstore without our permission. Any review copies submitted to us become property of The Country Bookseller. Due to the large number of consignment submissions, we are unable to mail review copies back to authors.
- Our standard consignment terms are: We take a minimum 40% discount (i.e., 60% of sales go to the author/consignor) and we keep consigned books in stock for a minimum of 180 days (depending on sales). Payment is made twice a year in June and at the end of December. It is the author's responsibility to deliver new inventory and pick up unsold inventory.
- Due to the heavy volume of submissions, the consignment review process can take several weeks. We will notify you by email of our decision. Please keep in mind that we do not usually accept consignment books during the busy holiday season. If you would like us to review and carry your book for the holidays, please make sure you have submitted your consignment application several months prior to December.
- The decision made by our buyers is final. As with all inventory we carry in the store, we retain the right for any final decision not to carry a book if we believe it doesn't fit our market.

We are pleased to have the opportunity to stock your book through our consignment program. Due to the economics of bookselling, it is not possible to carry every book published, and we must be especially diligent when approached to stock books outside our normal distribution chain. Our consignment program is an agreement between you, the author / consignor, and The Country Bookseller, the bookseller / consignee, to offer your book for sale in our bookstore. By leaving your books with us, you agree to abide by the guidelines in this agreement.

The Country Bookseller agrees to stock and sell the product described below for a term of 6 months (180 days) at which time the sales agreement will be extended or closed, based on sales reports. Sales will be reviewed twice a year in June & December, and payments will be mailed to the address provided. It is the responsibility of the consignor to keep their contact information current. The Country Bookseller is not responsible for any books lost, stolen, or damaged while in the store.

When the sales agreement is discontinued or closed, the products will be held for 30 days until the consignor picks them up. If the Consignor cannot be reached or fails to respond because of outdated contact information, the books will be donated.

By signing this agreement, the author / consignor agrees to the following:

- Set a reasonable price for your book.
- Divide the retail price according to standard publishing industry terms (if you are not familiar with these, please ask us).
- Pay for the shipping cost of the books to The Country Bookseller (consignors are responsible for the shipping costs for books when initially sending books and restocking books).
- Consignors are also responsible for the shipping cost of the books if they want any remaining books shipped back to them at the end of the consignment period.
- Offer your books at the same retail price at all outlets.
- Advise us which section of the store best suits your book.
- Inform potential buyers that your book is available at The Country Bookseller.
- Include the fact that your book is available at The Country Bookseller in any and all of your marketing and advertising (print, online, email, & social media).

The Country Bookseller will call or email you when we need to replenish the books. Please do not call or email to check on your book sales. _____(initial here)
